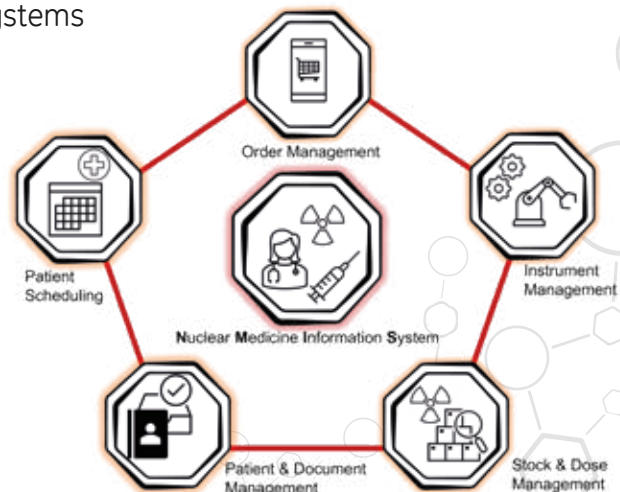
## Features are:
